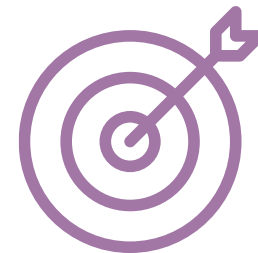


Molina Healthcare, Inc. is a FORTUNE 500 company, currently ranked 125.

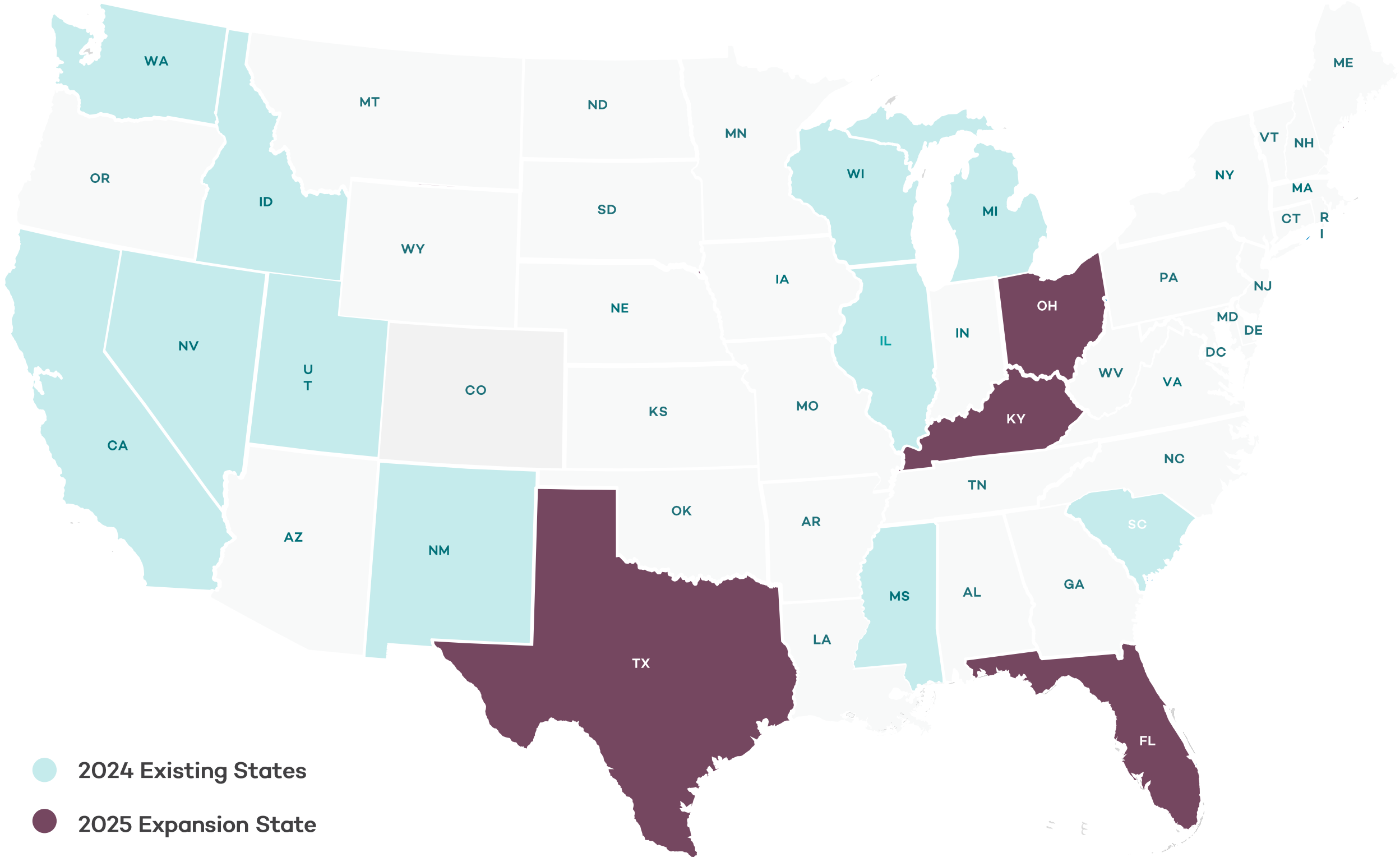

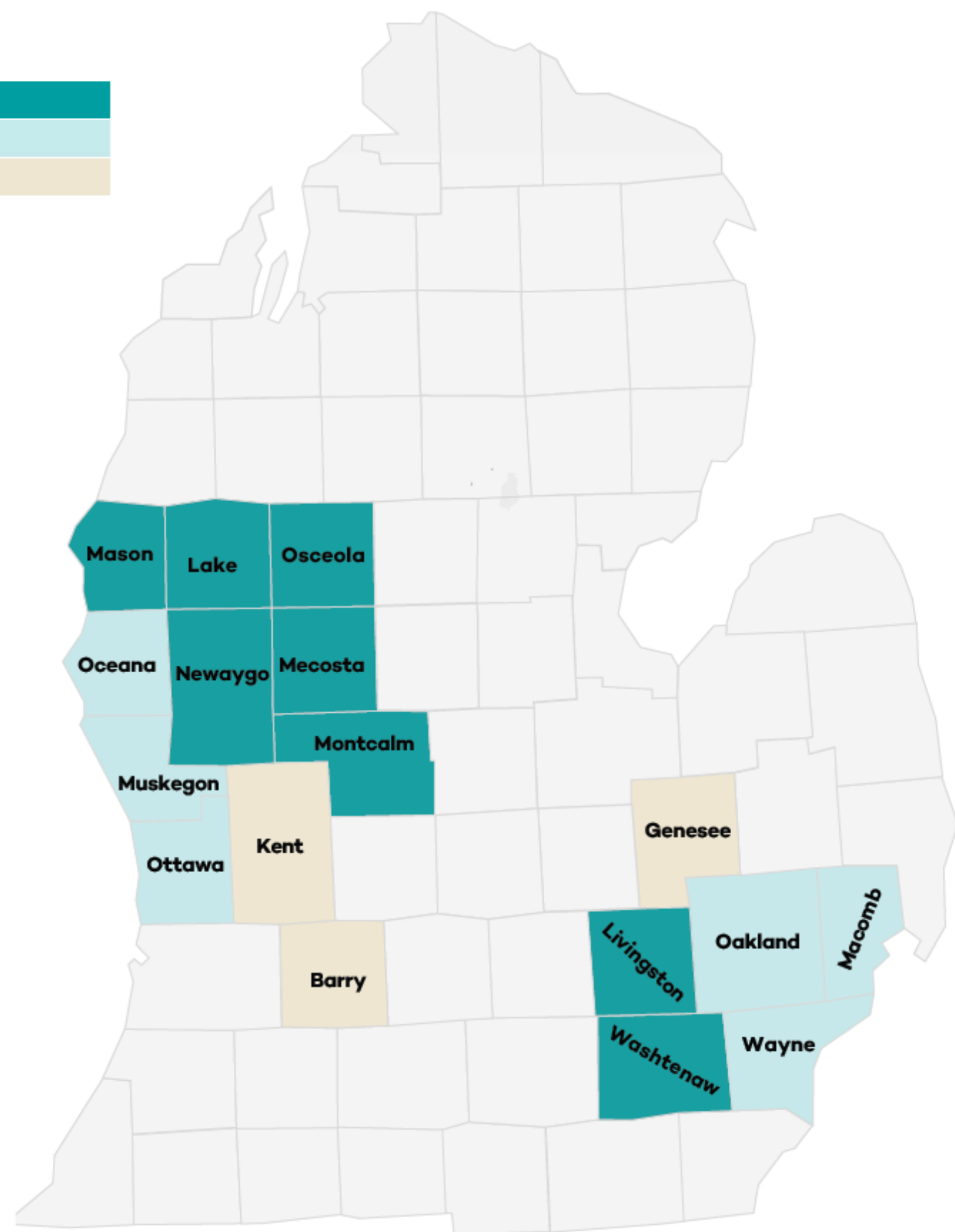

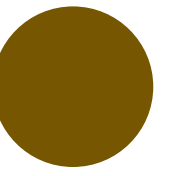

Molina is broadening our Bronze portfolio with new Bronze plans

Bronze 4 (FL, MS): Bronze 4 will retain a \$0-dollar medical deductible, with a \$3,000 prescription drug deductible. Only a minor adjustment will be made to conform to CMS MOOP limits (from \$9,450 to \$9,200).

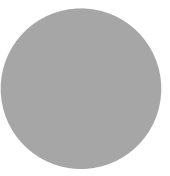
Bronze 9 (OH excluding Franklin County): Molina mid-deductible option and keeping MOOP in-line with the other products. The plan is expected to attract members with conditions who tend to exceed their MOOP.

Bronze 10 (OH excluding Franklin County): Molina low-deductible option and 50% coinsurance. Aimed towards low – medium level utilizers.

Standard Bronze (FL, MS, OH excluding Franklin County): CMS designed the 2025 standardized Bronze plan consistent with the cost share structure from their 2024 design. CMS has made only minor updates to the plan design.

Silver 1: The Silver 1 plan is intended to be “buy up” option for consumers over our Silver 12, offering more copayment cost-sharing, along with lower medical deductibles and MOOPs. Silver 1 retains member-friendly cost share features, such as copayments on primary care, specialist office visits, urgent care, PT/ST/OT, labs, and X-rays.

Silver 9 (Miami-Dade and Broward County): Lower deductible option tiering subset hospitals:
